Our jury will review each application and take into consideration a variety of standards including, but not limited to: quality, creativity/innovation, product presentation/packaging, brand cohesion, and value. While we are looking for experienced artisans, we are also on the lookout for newcomers who have created fresh and innovative products!

The Rockbrook Village® Craft Fair will be held on Sunday, June 2, 2019 from 11:00 am – 4:00 pm at 108th & Center in Omaha, NE. **No tables, chairs or canopies are provided—you must bring your own. Booth spaces are 10’x10’.** You may purchase up to two booth spaces if a larger space is desired.

Entry fee for this event is \$75 (\$150 for a double booth space). Nearly 100% of the entry fees are used to benefit our makers through the advertising and promotion of this event. Promotion will include, but is not limited to: Radio, Print ads, E-mail blasts, and Social Media promotion through both our Facebook and Instagram pages.

For the benefit of crafters and customers, the Rockbrook Village® Merchants’ Association is limiting the number of crafters within categories. Quality photos of your merchandise AND your display are essential to our decision making process.

Applications are due by May 1, 2019. All merchandise and displays will be evaluated for quality and originality. NO COMMERCIAL MASS-PRODUCED ITEMS ARE ALLOWED. Please apply early to secure your spot!
